# UAE – NEW DEADLINE FOR THE SUBMISSION OF POA FOR NEW TRADEMARKS APPLICATIONS



Among the recent changes of the TMO procedures, the legalized power of attorney should be filed within 90 days from the application's date. The above is applicable to new applications ONLY and no extensions are applicable.

# IRAQ – CONFIRMATION ON THE LEGAL TERM FOR THE SUBMISSION OF SUPPORTING DOCUMENTS FOR PATENT APPLICATIONS



Iraqi Patent Office confirms the Legal term of Six Months as from the Filing Date of patent applications in Iraq to fulfil the formal documents with Iraqi Patent Office; such term subject to extension at prescribed official fees.

The Saudi Authority for Intellectual Property (SAIP) issued a degree by which the Copyrights Law regulations were amended.



## **The main topics which were amended by the degree are as follow:**

### **Rules for the circulation of documents**

Authors must observe the provisions relating to the circulation of official documents issued in the Kingdom and obtain official approvals for the publication or translation thereof.

### **Database Protection**

Original databases are protected by the selection and arrangement of the contents as creations of mind and this protection does not extend to the data or the material contents itself.

### **Claiming rights**

Any co-author of any work has the right to individually request the undertake of precautionary measures in the event of any infringement of the copyright, and the right to claim a compensation for the damage caused in accordance to his share in the work.

### **Tracking right**

Authors of fine art works and original musical manuscripts; even in case of withdrawal their rights towards the original work, have the right to receive a percentage from these works sale profits, with exceptions to Architecture and Applied Art works.

### **Rental rights**

The Copyright owners has the right to rent the same in the Kingdom of Saudi Arabia, taking into account that the necessary precautions are taken; such as ensuring that there is nothing to prevent the rental of the work, troubleshooting of the potential rental obstacles, provide the consumers with awareness and directions related to the rented material, determine the rental duration and contractual relation in line with applicable laws and regulations.

### **Folklore**

The Saudi folklore is considered as public property of the state, and no one has the right to make any development or modification to it without obtaining approval from the respective authorities.
