KSA – Saudi Authority for Intellectual Property (SAIP) to launch New Search Database

SAIP released a new search platform through which users can search for registered IP titles namely trademarks, patents, and industrial designs.

The users can currently search, ONLY, for registered trademarks that were registered before SAIP from 1435 H onwards (2013). No official fees are currently applicable on the said service.

KSA - In conjunction with the Saudi Capital Market Forum 2023, Saudi Venture Capital launches a new product for the investment in pre-IPO funds

Saudi Venture Capital (SVC) announced the launch of the “Investment in Pre-IPO Funds” product and signed a memorandum of understanding with Tadawul during the Saudi Capital Market Forum (SCMF) 2023.

The “Investment in Pre-IPO Funds” product launched by SVC, as part of the Investment in Fund Program, comes to enhance exit opportunities through the initial public offering. The product also seeks to support the growth of the venture capital and private equity ecosystem in Saudi Arabia.

The memorandum of understanding aims to stimulate the listing of startups and SMEs on the stock market through stimulating investment in pre-IPO (initial public offering) funds and also through providing training to startups and SMEs wishing to be listed on the stock market.

SVC is a government investment company established in 2018 and is a subsidiary of the SME Bank, one of the development banks affiliated to the National Development Fund. SVC aims to stimulate and sustain financing for startups and SMEs from pre-Seed to pre-IPO through the investment in funds and co-investment in startups. SVC invested in 35 funds that have invested in 525 companies through 904 deals.

UAE – Publication of Trademarks Under Madrid Protocol in local Official Gazette



For the first time, the UAE trademark office publishes the acceptances of trademarks filed under Madrid Protocol in the Official gazette 264 of 08.02.2023. UAE joined Madrid protocol in December 2021. Since then, applicants were able to designate UAE. By releasing the OG 264, the international applications designating UAE are published for oppositions by third parties.

To oppose the trademarks in UAE, a local agent shall be appointed. The deadline to file the opposition is 30 days from the publication's date.



Egypt – Increasing in the Official Fees

Starting from February 22, 2023 , the official fees of patent substantive examination and trademark registration have increased , and it has published in the official gazette. Noting that our own charges will remain the same .
